### **Community Centre – Update**

Since edition 57 of the Quality Update (October 2017), Bovey Tracey Town Council has formally applied for Planning Permission from the Planning Authority (Teignbridge District Council) to build on the site of the Old Thatched Inn. The Town Council is currently eagerly awaiting determination of the submitted application. Over the winter, the Town Council has extended the appointment of the architect and has formally appointed the rest of the project team. Tender specifications are being prepared for the appointment of contractors.



As grant funders continually change their criteria, applications for external funding continue to be submitted whilst discussions are ongoing with the Information Centre Trust to consider options for any temporary relocation of the centre in readiness for when construction starts on site.

In 2017, Bovey Tracey Town Council resolved to prepare a Neighbourhood Plan for the parish of Bovey Tracey, which includes Brimley and Heathfield (see map), under powers given in the 2011 Localism Act. The process of creating a neighbourhood plan involves extensive consultation to identify community views about local development, scrutiny by an inspector and a parish referendum before it comes into force. Once adopted, the plan becomes part of the formal planning policy for the parish and will hold much more weight than the observations that the town council currently makes when it is asked to comment on individual planning applications.

A Neighbourhood Plan Steering Group, consisting of five town councillors and eight community representatives, was formed last December and has met monthly since. Its role is to oversee the preparation of the neighbourhood plan and to engage with the local community to ensure that the plan is truly representative of the ambitions of those who live and work in the parish. The steering group will maximise support for the neighbourhood plan by ensuring high levels of community consultation throughout the plan-making process.

#### Have your say about the future of our parish

Enclosed with this edition of Quality Update is a questionnaire designed by the steering group to gather the views of all those who live and/or work in the parish about its development over the next 15 years. There are four very good reasons for completing it:

- The neighbourhood plan will reflect the principal issues revealed in the responses to the questionnaire. Therefore the greater the number of responses, the more accurately the plan will mirror local views.
- The neighbourhood plan, once adopted, will give statutory force to the community's wishes on local development.
- The completed plan will also increase the Town Council's share of the money paid to Teignbridge District Council on local housing developments, giving the Town Council additional funding for the benefit of the parish.
- A neighbourhood plan, like any other planning policy, may be subject to challenge. However, a plan that can demonstrate high levels of community input will be more difficult to overturn so it is important that our plan is based on a high level of response to the questionnaire.
